

Don at Wings&Wheels

Don Putman, who was a Frederick City Policeman for many years brought us up to date on the use of Historic Tags issued by the State of Maryland. He brought in copies of the Section of Maryland Law defining the proper use of these tags and a copy is also included with this newsletter. There have been several instances where law enforcement officers have ticketed or warned drivers with Historic plates even when they were actually in compliance. Don says that officers may have differing interpretations of the how these tags can be used and that is where there can be problems. Some feel that you can only drive to a show or parade on these tags. The suggestion is to carry this Section of the Maryland Law in your vehicle. It does allow for <u>occasional use</u> but not to drive to school, to work, or for business purposes. The real culprits in this matter are the people who put Historic plates on a 20 plus year old clunkers used for daily driving. They have made this a problem for us collector vehicle owners and I personally get angry when I see one of those characters.



We have talked on many occasions about Clark's Corvair Parts good customer service and I experienced it first



hand. In August 2016, I bought a replacement fuel pump from them. It wasn't installed until March 2017 that it was installed. On a RARE nice day this January, I took the wagon out for a short drive but didn't get far. I smelled raw gas shortly after leaving and discovered fuel spurting out of the vent hole on top of the pump. I called Clark's and they immediately said they would send me a new pump for free and asked me to send the defective one back so they could analyze it. I paid the postage for the return and thought that was reasonable - I included a letter thanking Clark's for being there to supply the parts to keep our Corvairs running and also sent pictures of our car. About 2 weeks later I got a post card from Clark's informing me that they were giving me a credit on my

account in the amount of the postage I paid. Then a little later, I got a personal note from Cal Clark apologizing for the bad pump saying the manufacturer is still experience a 5% failure rate. He also said that our wagon looked fantastic and he was going to restore his 61 Lakewood when he finishes his 8/10 Cord. Now that is Customer Service. Ron's and Faye's Wagon at Wings&Wheels with its new fuel pump.

We went around the room to learn about everyone's Corvair happenings since the last meeting. With no further business, the meeting adjourned at 8:50



CORVAIR TRIVIA

Last month's question – In 1961 GM introduced their "senior compacts" Buick Special, Olds F-85, and Pontiac Tempest. These cars were also unit body construction and shared some features with the Corvair. Which of the 3 had the most shared features with the Corvair? Bonus question: 1 body shell was used by all 4 - Corvair-Special-F85-Tempest – which was it?



Next to the Corvair, the 1961-1963 Pontiac Tempest had the most unconventional drive train of period American automobiles. Under the leadership of John Z. DeLorean, Pontiac engineers developed a slant 4 cylinder engine which was one half of a 389 V8, connected via a flexible cable drive shaft to a rear mounted transaxle shared with the Corvair You can see the similarity in the "greenhouse" of the '62 Tempest Coupe pictured to the early Corvair Coupe.



Subject: Historic Tags.

The following is taken from Maryland Vehicle Law:

13-936 Historic Motor Vehicles

- (a) defined; motor vehicle, motorcycle, or truck that
- 1) is at least 20 years old,
- 2) has not been substantially altered from the manufacturer's original design, and
- 3) meets criteria contained in regulations adopted by the Administration.
- b) "Remanufactured or reconstructed vehicle" 'Historic Motor Vehicle' does not include a vehicle that has been remanufactured or reconstructed as a replica of an original vehicle. (see street rod)
- (e) Special registration requirements-

In applying for registration of a historic motor vehicle under this section, the owner of the vehicle shall submit with the application a certification that the vehicle for which the application is made:

- (1) Will be maintained for use in exhibitions, club activities, parades, tours and occasional transportation; and
- (2) Will not be used;
 - (i) For General transportation;
 - (ii) Primarily for the transportation of passengers or property on highways;
 - (iii) For employment;
 - (iv) For transportation to and from employment or school; or
 - (v) For commercial purposes.

13-937.1 Street Rods

- (a) defined; motor vehicle that;
- 1) is 25 years old or older; or
- 2) has been substantially altered from the manufacturer's original design.
- (d) Special registration requirement-

In applying for registration of a street rod under this section, the owner of the street rod shall submit with the application a certification that the vehicle for which the application is made;

- (1) Will be maintained for use in exhibitions, club activities, parades, tours, occasional transportation, and similar uses and
- (2) Will not be used:
 - (i) For general daily transportation; or
 - (ii) Primarily for the transportation of passengers or property on highways.
- (g) Exception from equipment requirements--Unless the presence of the equipment was specifically required by a statute of this State as a condition of sale when the vehicle was manufactured, the presence of any specific equipment is not required for the operation of a vehicle registered under this section.
- (h) Exemption from inspection requirements--A vehicle registered under this section is exempt from any statute that requires periodic vehicle inspections or that requires the use and inspections of emission controls.

A Corvair is essentially a poor man's Porsche 911.
Both cars are powered by flat-six engines that

are located behind the centerline of the rear axle, yet, instead of having Porsche's seating arrangement that only really accommodates two passengers, the four- and sometimes five-passenger Corvair provides fun for the whole family.

In Corvair World, there are two different owner groups: those who prefer the 1960-'64 first-generation cars, and fans of the second-generation 1965-'69 models. The early cars offer a distinctive, more vintage character, while the later cars feel a bit more modern, and, according to their owners, handle better. Of course, there are many Corvair fans who like both generations, of which I'm one.

Evidently, owning a Corvair is so addictive that few enthusiasts own just a single example. In fact, some people are so passionate about Corvairs that they own several; it's not uncommon for some folks to own a half dozen or more.

What makes one want to own more than one Corvair comes down to the many different models that were made. Besides sedans, hardtops, club coupes, and convertibles, there's the cool-looking Vista-roof sedans and Lakewood wagons, Corsa and Monza models, Spyders, and two-carb, four-carb, or turbocharged engines. There's also the Greenbrier Sport Wagon van, Corvan panel truck, and Rampside pickup. And for those who prefer a more performance-oriented car, there's the Yenko Stinger and Fitch Sprint. No wonder it's impossible to own just one Corvair!

If I was a lot younger I would have a barn full of Corvairs. My goal would be to own one

Corvair Aspirations

For way too many years I've been wanting to own a Corvair. While many people have little regard for this attractive compact from Chevrolet, I have long believed that Corvairs are one of the automotive world's finest mechanical masterpieces ever built. The engineering principles that are the foundation for what many considered to be a car way ahead of its time, and one of



of every model ever built, and to restore them to 100-percent factory-correct perfection. I would also own some that would be modified, because

a Corvair fitted with Torq Thrust mags and lowered suspension looks oh-so alluringly right. But for now, I will be satisfied with a 1965-'66 four-carb, four-speed coupe, or even a later model, which had more upgrades.

In the meantime, to satisfy my Corvair obsession, as I mentioned a few years ago, I am writing two books on Corvairs, with volume one scheduled to be published in May of 2019. The first book will focus on original and authentically restored cars, with the follow-up book being about Corvairs that have been modified. Thus far, I have found several one-owner cars, along with some spectacular Corvairs that are low-mileage originals still wearing their factory-applied paint. Well-restored and concours-quality cars will be included too, along with Yenko Stingers and Fitch Sprints. Yet, my search continues for more interesting examples.

If you want to witness firsthand the hardcore enthusiasm that Corvair fanatics have for their beloved air-cooled Bowtie-badged machines, I suggest you attend the upcoming national Corvair convention. It will be held July 23-28 at the Double Tree hotel in Pittsburgh, Pennsylvania. The all-Corvair concours is scheduled for Tuesday, July 24, with an autocross at The Mall at Robinson on Friday, July 27, followed by a People's Choice Car Display on Saturday, July 28.
