It's Election Season!! - Nominations for RMC Officers Being Accepted By The Board Through November 1st

Below are excerpts from the RMC Bylaws, specific to the election of Officers and members of the Board. Please refer to the Club Bylaws for full details and job specific responsibilities, and volunteer to support the Club as a leader in 2020!

ARTICLE IV - OFFICERS

SECTION 1. Officers: The elected Officers of the RMC shall be: President, Vice President, Secretary, and Treasurer.

SECTION 2. Election: A call for volunteers to serve as Officers and board members will be announced at the October meeting (**DONE**). Nominations for Officers and board members shall be submitted and accepted to the ballot during the November meeting.

Officers will be elected by majority vote of the members present at the December meeting, and will take office on January 1.

ARTICLE VII – BOARD OF DIRECTORS

SECTION 1. Board Composition: Board of Directors shall consist of the elected Officers (President, Vice President, Secretary, Treasurer), the immediate past President, and one Member-At-Large from the general membership. The Member-At-Large shall be elected in accordance with Article IV, Section 2.

A brief 9-11-19 stair climb story

As many of you are probably aware, for a number of years I've been doing the 9-11 memorial stair climb at Red Rocks Amphitheater near Morrison, CO. This is to honor the 343 firefighters who lost their lives during 9-11, and now those who have passed away from 9-11 related illnesses. This year has been busy so "training" was difficult, along with some annoying health issues. I'm glad to say I was able to do it and I have a Corvair story to go with it.

I typically drive a Corvair, usually my white 1966 Monza. I was changing shoes in the parking lot with the trunk open and a young fellow of about 6 years old named Jackson was running around using up excess kid energy. His dad is obviously a firefighter because he was wearing bunker gear. His mom was trying to track Jackson's travels through the parking lot.

Jackson runs up to the car and says (paraphrasing) "What happened to your car?!" "What do you mean?" "There's no engine!?" "How did you get here?!" By then his mom walked up and told me that Jackson is very interested in cars and watches car shows a lot. He was aware that usually engines are in the front and trunks in the rear. I asked him if he wanted to see the engine and zip, we were looking at that. He had a really concerned look on his face (really hard to describe but furrowed brow, etc.) and he said, "That's not right!" and headed toward the front of the car again. I



explained to his mom what kind of car it is, it was made by GM in 1966, the engine is in the rear, it's air cooled... Maybe she will remember enough or be interested enough to look them up on the web.

Jackson's next move was to go pull on the door handle which concerned his mom a lot. I told her it was OK for him to get in and sit in it, so I opened the door for him. Just like SeeMore, that was a hit. He checked out the back seat and front seat plus controls and kneeled on the front seat to steer it.

Maybe a future Corvair collector but in any case, the whole encounter was pretty entertaining, and much more cheerful than climbing stairs in a memorial service

Standard Business:

Minutes from past meeting: The September minutes were approved.

Treasurer's Report: The end of Sept balance was \$5,300.32. The Treasurer's report was approved. CORSA Admin Fee \$35 was paid in Sept. State Periodic Report filed, couldn't tell it took payment, ultimately paid 9x and had to correct with bank.

Mailbag: Nothing.

Old Business:

Activities review:

○ Sept 28, Fall Tour. Re-routed drive up, got entire upstairs of restaurant, and the food was good. The town was busy.

○ Sun 29th Corvairs and Cheeseburgers. Lynnette Church (Chad's sister) attended with Spyder. 26 present, 13 Corvairs.

Upcoming events:

○ Oct 12 in Parker, show at the Vehicle Vault--a garage condo and museum complex at Parker and 20 Mile Road.

○ Sat October 26, 5 pm, Buckley Air Base, Trunk-er-Treat, enter at the Mississippi gate. If you don't have a government ID, you will need to pre-register. An email will follow with details.

○ 12/14 Holiday Party, 1-4, gift exchange, Mimi's, First drink and appetizers free. Collecting unwrapped gifts for Toys for Tots. More to come in newsletter.

New Business:

• Rick Beets reported on the CCCC meeting last Wednesday. The lobbyist talked about 2020 legislative session, there's not a lot on radar of concern to hobby. The Havana Cruise will be June 13, 2020, but it may be earlier in day due to weather. There may also be some change of venues. The Air Show and Swap Meet will be August 1. It's a major air show year but scaled back from 2 years ago, with no major attraction like Thunderbirds. The Airport Authority will handle parking and use shuttles. There is a change to free parking but CCCC would receive a part of gate admission this year.

• Kurt from Hagerty, our hosts this and next month discussed collector car insurance starting with a video. They insure basically all pleasure use vehicles. They have a number of levels of insurance and work with each owner to determine value. There is a Driver's club with several levels and benefits, includes magazine, access to evaluation tool, discounts and club and hobby activities. There is a free newsletter for all, member or not. Discussion topics included Guaranteed, stated, and agreed value, limitations on miles driven by various companies and in different states.

• Michael Jessmon from 3D High Definition Car Care presented finish detailing options including ceramic coatings. He does paint correction and restoration.

- Enamel vs modern clear coat? Michael indicated that a single stage enamel when polished comes out better than new. By comparison modern clear coat cars (as new) are just painted, not wet sanded and polished.
- For winter use, he recommends a ceramic coat. The paint has to be perfect first, as the ceramic seals in anything under it. This gives it a 3D depth appearance. Steps are to wash, then rub down with 91% isopropyl alcohol, then apply ceramic finish 12" x 12" area, wait 2 minutes, and wipe it off. Ceramic gives it some scratch protection, but not against chips.
- Waterless wash towels: were discussed, there are many types. Be careful as some synthetics can scratch.
- What does clay barring do? It is a multi-step finishing system that starts with medium clay that is like sandpaper. Incrementally gets finer. Michael expressed concerns about sediment build up inside the clay causing scratches.

- Most important advice: Use soft water to wash your paint finish, as hard water can be corrosive to the finish.
- 2020 nominations—Call for officers, need to be nominated in November meeting. Ed is looking to step down. Mike, John, Rob Chris, and Paul willing to stay. Ken (member at large), unknown, was not present.
- Dues Reminder, \$25 annual dues due at first of year, pay by 2/28 or be dropped from club. Several reminders will go out in various forms.
