## MINUTES

### MEETING PLACE

After the election of officers, Harvey Lee reported the first order of business regarding meeting place for the club's future meetings. Consideration of \$10.00 was requested for the use of the First United Presbyterian Church. It was voted upon and accepted. Mr. Lee also indicated that possibly the club and its members might consider other locations for future dates. It was also suggested that the first Wednesday of the month would be the plan for future club meetings at the church presently. The contribution was voted on and accepted. The contribution is basically for heat and light. Jim Doody confirmed Mr. Lee's proposal. The proposal was accepted.

### CLUB DUES

Our new President proposed dues for the club and suggested that we might open the meeting by discussion regarding dues. Jim Doody offered for consideration \$3.00 dues. ### INSURANCE

A discussion developed regarding antique or special car insurance under-written by the Zurich American Insurance Company. It was discussed that considerable discount might be had on automobile insurance policies for antique and special

cars if certain requirements are made regarding mileage limitations. The agency that would handle this particular type of insurance is the J.C. Taylor Insurance Agency, 8701 Westchester Pike, Upper Darby, Pa. 19082.

Harvey Lee also indicated that he had a similar policy of this sort. However, further information will be obtained and passed on to club members.

#### WINTER STORAGE

John Garrison offered the use of his barn for dry winter storage for club member's cars.

#### COOPERATIVE BUYING

The possibility of obtaining a club discount for buying parts for Corvairs was proposed. It was agreed that Harvey Lee would check with Sweeney Chevrolet about a price discount on parts. Mr. Lee agreed to make a report at our next meeting.

#### VITON SEALS

John Garrison reported that the Viton Seals for O-rings might be obtained for \$8.00 per set. Solar Auto Parts offers the same set for \$9.95. However, they also offer a 10% discount for Corvair parts. *\$10.95 as of 10-73*

#### CHECKING ACCOUNT

Jim Doody agreed to check into the possibilities of obtaining a free checking account for our newly formed club. He agreed to make a report at the next meeting.

#### ADJOURNMENT

The meeting was adjourned at 9:28 p.m. after which a technical session took place.
