### From the Director

We Made It.....

Shortly after taking the office of Treasurer for the club two years ago, I realized we were overspending by about \$3000 each year. This was not new news, but I felt something had to be done to keep the club alive. So, I set out to balance our budget.

The first step was to see where the money was coming from and where did we spend it. I had good data from the previous few treasurers, so I put together a few pie charts and a bunch of statistics showing income vs expenses. This showed we had been an "event financed" club for many years. With World of Wheels, along with Orphan Auto picnic, parades and ALL other income events now gone, we had transformed into a "dues financed" club.

This also showed our expenses had been cut to the bone, with about 50% for monthly meeting space and 50% spent on the Airhorn.

Next step the Board went to work on a plan to turn this around. Do we raise dues? No, they would have to more than double. Do we find a smaller meeting space? No, we would have to find a much smaller and noisier place and savings still would not be enough to balance the budget.

Airhorn rose to the top. And as they say "the rest is history".

By slightly changing the dues structure to allow for a \$36 "fee" for a printed *Airhorn*, we could just about break even. This was not a new idea for our club, but I think the timing was better. Since many of us use email and iPads to keep in touch with friends, family and grandkids, this time a PDF version of the *Airhorn* was easily accepted.

And the membership responded to this news with MANY member donations (even \$1000 anonymous donation) so we did balance our budget for 2023.

Thanks to the generosity and flexibility of our members and the hard work of our board, as I close out my two-year term as treasurer, rather than over spending by \$6000, we now have a balanced budget.

We are well on our way to many more fun filled years of CCE.

## **CCE Elections 2025**

**Board** of **Directors Elections:** Elections members to the 2025 CCE board of directors takes place at the October CCE Meeting. The October Airhorn is delivered to members a week early and contains the ballots. PDF delivery members receive their ballots in separate postal deliveries, at the same time the printed Airhorns are mailed out.

**Election Process:** CCE does not elect specific individuals to be President, Vice President, Treasurer, Secretary or Director at Large. Instead, five members are elected in general to be on the board. At the first board meeting after the election, in November, the board members decide amongst themselves who will serve as those specific officers.

The election ballots are collected at the October CCE meeting and counted at the midmeeting break, with the results announced after the break. The new board takes office at the November board of directors meeting.

**Current Board:** The CCE board currently consists of the following members:

- Kirk Parro, President (Second term)
- Mike McGowan, Vice President (First term)
- Kevin Kloker, Secretary (First term)
- Mike Charewicz, Treasurer (Second term)
- Paul Polster, Director at Large (First term)

**Eligibility:** According to the CCE Constitution, of these current board members, only those who are not currently serving their second consecutive term are eligible to run again.

On this board, Kirk Parro and Mike Charewicz have served

two consecutive elected terms (2023/2024) and thus will be not placed on the ballot.

**Automatically Nominated:** Mike McGowan, Kevin Kloker and Paul Polster are on their first terms and are automatically nominated, however only two of them can be elected to serve a second term. All accepted nomination except for Mike McGowan. That leave two incumbent candidates:

- Kevin Kloker
- Paul Polster

**New Director Candidates:** Three new directors are to be elected, nominated from the general membership. Over the nominations months of August and September, the following new board candidates were nominated:

- · Ray Behrends
- · John DiProva
- Diane Johnson\*
- Lin Parro
- Jeff Wentz

\*Subsequent Declination: After the September meeting, Diane Johnson sent me an email saying she wished to decline her nomination for election to the board. Therefore, I removed her name from the ballot.

**Ballot Categories:** The ballot will contain two categories.

- One will be the list of incumbent board members who have agreed to run for second terms. Members will be directed to vote for no more than two candidates in this category.
- The second will be the list of non-board members nominated by the general membership at the August and September general membership meetings. Members will be directed to vote for three candidates in this category.

**Ballot Deliveries:** The ballots will be mailed to members a week before the October general meeting, generally in the *Airhorn*. Members who receive digital PDF copies of the *Airhorn* will receive separate printed ballots in the mail. No ballots will be included in the digital *Airhorns*. Ballots are sent out only to active dues paying members. Individual memberships will receive one ballot. Family memberships, representing a member and a spouse/partner, will receive two ballots.

**Counting Ballots:** The ballots will be collected counted at the October CCE meeting. The results will be announced after the midmeeting break.

**New Board and November:** The five newly elected directors will attend the November board of directors meeting. At that meeting, they will decide among themselves who will serve as President. That President will then select who will serve as Vice President, Treasurer, and Secretary. The remaining director will serve as Director at Large.

The new board will participate in a joint November board meeting with the old board. The new board will officially introduced take office at the November general membership meeting.


The 2026 Convention will go east to Gettysburg, PA. We are looking for Central Division chapters interested in hosting for 2027 so contact your division director for more information!

## **CCE 2024 Fall Tour**

I can't begin to write anything about CCE's Fall Tour without first thanking Ted and Pat Malo. When Lin Parro asked club members for suggestions of places we could go, Ted stepped up and presented her with a brochure for the Wisconsin Automotive Museum. If it wasn't for that, we would have never had the opportunity to experience this unique automotive gem. And, as it turned out, they also gave us a great tip on where to go for dinner. Thanks Ted and Pat!

Our group consisted of four Corvairs, one Chevy Volt, and four assorted "other" cars. Our first destination was a car show at Old Falls Village in Menomonee Falls, a (what should have been) pleasant one hour drive from the Wisconsin Welcome Center. However, the Wisconsin Dept. of Transportation had a different idea in mind for us and closed our exit ramp. As a result of this unexpected detour, we ended up in two separate groups. But, thanks to the gods of GPS, both groups miraculously ended up at our destination at exactly the same time!

Old Falls Village is a beautifully wooded eighteen acre site including a large lawn area, eight historical buildings, a performance stage, a Biergarten featuring beers brewed in Wisconsin, and a large covered picnic pavilion. And, as an added bonus, they were having their annual car show that day. After our guided tour of the buildings, everyone was free to partake in a beverage of their choosing, grab some lunch, and enjoy the car show.

We then headed to Hartford and the Wisconsin Automotive Museum, Wisconsin's largest car museum. It features a display of classic and vintage autos and artifacts, plus the largest assembled group of Kissel luxury automobiles. Never heard of a Kissel? Me neither. An estimated 26,000 Kissel cars were made locally in Hartford from 1906 to 1931. Fewer than 150 complete Kissel automobiles still survive, with 25+ of them currently at the museum.

In addition to the Kissel, featured displays in the museum were the Nash Club of America and the Wisconsin Short Track Hall of Fame. Not to mention the Pontiacs, Studebakers, Chevrolets (including a 1964 500 Corvair), Kaisers, Fords, and other cars from around the world. The collection was rounded out by displays of automotive artifacts such as a 1965 Corvair 180 turbo engine, gas pumps, signs, license plates, oil cans and other petroliana.

Oh, let's not forget the #1003 Steam Locomotive. Built in 1913, the 250 ton Soo Line steam locomotive is housed at the museum and makes appearances several times a year for special events.

After the museum closed, we walked two blocks, through the town's Oktoberfest celebration, to the Mineshaft restaurant for dinner. After eating our fill, we embarked for the journey home.
