Minutes of Meeting, July 6, 2016

The meeting was held at the ColoRODans clubhouse, 209 Kimbark St., Longmont Colorado.

The meeting was called to order at 7:35 pm by President Dick Thompson. Officers in attendance were Dick Thompson, president; Samantha Baker, 2nd vice president; Dick Fritz, secretary; and Tom Kay, treasurer. 30 member clubs were represented. Dick Thompson thanked the ColoRODans for hosting this meeting.

Political Committee: Leo Boyle noted that the primaries last week settled who the candidates will be in the November elections. Our concern will be who will be on the transportation committees since legislation regarding vehicles will start out there. Although Leo will advise, donation selections will be made by the PAC committee. Our goal is to promote visibility of the collector car community. Besides making donations, individuals should contact candidates and where possible donate time to candidates' campaigns.

The committee has not yet undertaken seeking contributions from major car collection owners and managers.

Havana Cruise: Dick Thompson summarized the cruise, including preliminary finances which look very good. Mecum Auction (July 8-9) and National Collector Car Appreciation Day (July 8): The Mecum organization stepped in to help the CCCC organize a display of collector vehicles on the 8th at the parking lot facing the Convention Center where the auction is being held. The news media have been notified and will assist in publicizing both events. CCCC has arranged for approximately 12 vehicles, including a fire truck and police car from the Fire Fighters Museum.

SEMA Show (November 1-4): In recognition of our mutual efforts to promote legislative protection of the collector car hobby, SEMA is granting CCCC members eligibility to attend the SEMA show in Las Vegas. All attendees receive an identifying pass in their name. The requirements for each attendee are:

Membership in a CCCC club;

Membership in the SEMA Action Network (free via link: semaSAN.com/join)

At least 16 years of age.
