Minutes of Meeting, 3 October 2018

The meeting was held at **Cars Remember When**, 4505 S. Santa Fe Drive, Englewood Colorado.

The meeting was called to order at 7:31 pm by President Dick Thompson. Officers in attendance were Dick Thompson, President; Tom Mansfield, 1st V.P.; Dick Fritz, secretary; and Tom Kay, treasurer. 36 member clubs were represented along with three associate members and four individual members. Ira Sanders from the Z Car Club of Colorado was welcomed as a guest. Thompson introduced and thanked our hosts, Ryan Konrad and Amanda Plank, who described the **Cars Remember When** facility which provides service, storage, and sales of collectable classic cars. They also provided food and drink for this meeting.

Legislative: Leo Boyle presented an overview of the 2018 State Ballot Information Booklet (Blue Book) which is sent out to all voters in the state in preparation for the November 6th election. He noted that this is a very complex election, with 13 statewide issues on the ballot. He urged everyone to take the time to study the measures. Of the 13 statewide measures, six were referred by the legislature while the remainder came from citizen initiatives. Obviously, commercials on TV and in print portray only one side of an issue, but the blue book provides arguments for and against each. There are two propositions, 109 and 110, both of which deal with transportation issues and these should be carefully studied.

Leo noted that the election will cause many changes in the makeup of the Colorado House and Senate, and we can only recommend that club members get to know their representatives. We need to make friends, not enemies. CCCC does not endorse specific candidates. By the time of the January CCCC meeting Leo expects to have information about the legislative landscape for 2019.

Minutes of the September meeting were approved as published.

The Treasurer's Report was approved unanimously.

Nominations for 2019 CCCC officers: In accordance with the bylaws, nominations were opened. In spite of the great pay and benefits (?) no new candidates appeared. The current board officers are willing to continue. Nominations will remain open (you still have the opportunity) until the election at the November meeting.

2019 Air & Ground Show, CCCC Swap Meet and Car Show: Rocky Mtn. Metro Airport is willing to have us put on the swap meet and car show in August 2019 but there will not be an air show at that time. RMMA hopes to put on the air shows every other year. We will hold a planning meeting for the 2019 event on Monday, October 8, 4:30 pm at the Great Scott's restaurant at US36 and Pecos St., north Denver.

SEMA Show: 25 members of CCCC-affiliated clubs have been cleared to receive complimentary passes to the show (Oct. 30 – Nov. 1 in Las Vegas).

Communication with clubs: Some club members have indicated that they were not aware of CCCC events such as the recent Air & Ground Show and legislative work by Leo Boyle. We urge club representatives make reports to their membership and include information in club newsletters. Copies of the minutes are sent to club editors when we have addresses.

The Latest Scoop: This publication by Tracey Ellis in Loveland provides details of upcoming collector car events and coordinates with the CCCC. The publication includes a listing of car clubs but at least 8 clubs have not taken advantage of this means of reaching new members. The web site is www.scoopautoevents.com.

Trunk or Treat events (like trick or treat): The children's event at Buckley AFB will be on October 27, 1800-2000 hours (Ok, for the non-military that is 6 to 8 pm).
