### Minutes of Meeting, 7 November 2018

The meeting was held at the Forney Museum of Transportation

The meeting was called to order at 7:31 pm by President Dick Thompson. Officers in attendance were Dick Thompson, President; Tom Mansfield, 1<sup>st</sup> V.P.; Dick Fritz, secretary; and Tom Kay, treasurer. 31 member clubs were represented along with one associate member and two individual members. Rick Beets of the CORSA Corvair Club of Colorado and Sara Bain from Hagerty Insurance were welcomed as guests.

**CORSA Corvair Club:** Rick Beets reported that their club has voted to apply for membership in CCCC. Following discussion the application's approval was moved, seconded, and passed unanimously.

**Legislative:** Leo Boyle was unable to attend.

**Minutes** of the October meeting were approved as published.

**Treasurer's Report:** Treasurer Tom Kay reported balances as of the end of October:

The Treasurer's Report was approved unanimously.

**Nominations for 2019 CCCC officers and election there of:** The floor was opened for additional nominations, followed by complete silence. Since the current officers have agreed to continue in their present offices, it was moved and seconded that nominations be closed and the current officers be reelected. The motion passed by majority vote with one objection but the First Vice President was overruled.

**Meeting with Colorado Department of Revenue officials:** John Mack summarized the meeting he, Dick Thompson and Leo Boyle had with Kyle Boyd and Adam Wilms of the DoR to clarify guidelines issued to county clerk and recorders regarding registration of vehicles with **collector series license plates**. The Department is using a new computer system known as CSTARS which may have misled county offices. As reported in an attachment to the October CCCC meeting minutes, there are three categories of vehicles eligible for collector series registration:

- Vehicles built 1975 and earlier;
- Vehicles built 1976 and later that were registered as collector items before September 2009;
- Vehicles at least 32 years of age.

In addition, CSTARS will soon include dual-registration for vehicles with **Year-Of-Manufacture plates**. In any event, it is imperative that owners with YOM plates carry the regular plates as well as certification of the YOM registration with the state.

**2019 Air & Ground Show, CCCC Swap Meet and Car Show:** Dick Thompson met with Rocky Mountain Metro Airport (RMMA) officials to confirm plans for an air and ground show, to include the CCCC swap meet and car show in 2019. The RMMA officials noted that there are three classes of air shows;

- Class 1: Full professional air shows that may include military teams such as the Navy's Blue Angels or Air Force Thunderbirds;
- Class 2: Hired aerial aerobatic performers such as those putting on demonstrations at the 2018 event;
- Class 3: Performances with arranged fly-bys and fly-ins.

We and RMMA intend to have the 2019 show be of the third category, and RMMA is negotiating for a Class 1 show in 2020. For CCCC, the 2019 swap meet and car show will be in the same area as 2018 and with enhanced parking and shuttle services for spectators and buyers. Note the date of **August 3, 2019** in club calendars.

**Cruiz'n Havana 2019:** The 2019 Cruise will utilize three sites, eliminating the Gibby's location due to behavior of some drivers after the 2018 cruise ended. Clubs are encouraged to note the date of **June 8** in club calendars.

**Presidents' Night:** Our annual Club Presidents Night will be on **February 6** and will focus on encouraging young people to join the car collecting hobby. Location is still to be determined.

**Mickey Froid Benefit:** The DJ known as Da Boogieman suffered a stroke while performing at the Highlands Ranch HotRodders show and now needs medical assistance. There will be a benefit at "The Venue", 1451 Cortez St. (vicinity Pecos and US 36) in north Denver on Sunday, November 18 between noon and 6 pm. We urge members to attend as Mickey has been a frequent supporter of car club events.

It was noted that the father of Christof Kheim (Director of the Forney Museum) passed away on October 25.

CCCC often receives requests for special cars for weddings. Rich Somers used to handle these but it is not known if he does this or if someone makes a business of providing such vehicles. There were anecdotal stories of the risks of abuse of vehicles so owners are cautioned.

**Next Meeting:** Wednesday, December 5, 7:30 pm, at the Forney Transportation Museum, 4303 Brighton Blvd., Denver Colorado. Budgets for 2019 will be presented and discussed. We need to encourage volunteers to serve on CCCC committees.

The meeting was adjourned at 8:28 pm.
