### Minutes of Meeting, 6 July 2022

The meeting was held at the Forney Museum of Transportation, 4303 Brighton Blvd., Denver Colorado

The meeting was called to order at 7:31 pm, or maybe 7:27 pm, by President Dick Thompson. Officers present were President Dick Thompson, 2<sup>nd</sup> Vice President Calvin Craig, and Secretary Richard Fritz. Leo Boyle was unable to attend.

**Forney Museum Featured Exhibit:** Christof Kheim (our meeting's host) described the featured display of "Cars of 1957". The Museum would welcome 1957 model cars from CCCC clubs. The cars or trucks would be on secure display August 4<sup>th</sup> through October, protected from rain and hail storms. Cars are to be brought in the week of July 25<sup>th</sup>. **Club rejoining:** The Military Vehicle Collectors of Colorado (MVCC) is applying to become a member of CCCC and they have met all the requirements in the CCCC Bylaws. Chris Raasch described the activities of MVCC and submitted their application. After discussion, approval of the application was moved, seconded and passed unanimously. MVCC is concerned about consequences of Colorado Senate Bill 19-054 regarding "Surplus Military Vehicles" and the interpretation by the Department of Revenue that such vehicles can only be titled and registered for off-road use. When such vehicles come due for registration renewal the DMV now requires the change of designation for them.

**Minutes:** The minutes of the June CCCC meeting were approved after an objection to the official start time (7:30 or 7:31) was dismissed.

**Treasurer's Report:** There was no treasurer's report as Samantha is in quarantine due to Covid.

**Airport Show (August 6 at Rocky Mountain Metro Airport):** Dick Thompson discussed plans for the Airport Show. Approximately 13 volunteers are still needed in 2-hour shifts. Tasks itemized in the June meeting included:

- Spectator parking at Eldorado Ridge Parking lot, 11101 W. 120<sup>th</sup> Ave. No money collected.

- Money Handler – someone to collect the money at the Car Show gate and at the Swap Meet/Spectator gate. Golf cart provided.
- Help John Ehrlich at swap meet/spectator gate.
- Pass out programs to those in line to get into car show. Only needed 8 – 10 am.
- Collect \$10 per car at car show gate. Two volunteers 8-10 am only.
- Traffic directors, car show gate, one at stop sign, one to direct people to car show area or spectator parking. Need three to work 6-8 and 8-10 shifts.
- Truck and trailer parking director at Spartan College

**SEMA:** The SEMA Show in Las Vegas will be held November 1-4. In the past CCCC has been allocated 15 complimentary passes but John Ehrlich has not heard if this will be approved again this year. If approved, an applicant must be a member of a CCCC club, be a member of SEMA Action Network, and at least 18 years of age. For details, contact John Ehrlich at 303-526-6805.
