### Minutes of Meeting, 7 September 2022

The meeting was held at the Forney Museum of Transportation, 4303 Brighton Blvd., Denver Colorado

The meeting was called to order at 7:31 pm, by President Dick Thompson. 20 member clubs, and two individual members were in attendance. Officers present were President Dick Thompson, 1st Vice President Tom Mansfield, 2<sup>nd</sup> Vice President Calvin Craig, Treasurer Samantha Baker, and Secretary Richard Fritz.

**Privately owned Military Vehicle registration and titles:** Leo Boyle is working with the Military Vehicle Collectors of Colorado to attempt to change the DOV's interpretation of Senate Bill 19-054 which has led to cancellation of on-road use of surplus military vehicles. Even the sponsors of SB19-054 do not understand the state's interpretation. Leo intends to meet with the writer of the bill.

The show was profitable for the Council. Most comments from visitors were favorable, but heat on the concrete and the lack of shade were the objections from some. The lack of vehicles from many CCCC clubs was disappointing. All comments, good and bad, will be considered in planning a 2023 show.

**SEMA:** John Ehrlich has received authorization for CCCC-member club individuals to attend the November 1-4 SEMA Show in Las Vegas. There are only a limited number of these comp tickets available as SEMA does not want to weaken their trade show status.
