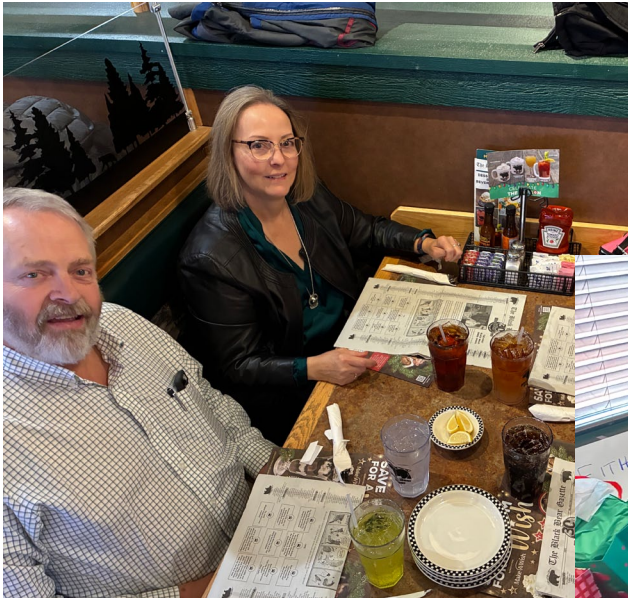

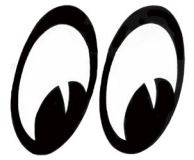

A New Year, with a dab of cold weather to add at least a touch of seasonal feel, and we're all staring at the fresh slate of CE 2026. I've always thought it odd that turning over the 12th calendar page has such an outsized impact on a large swath of humanity. ### ***Whither Goest RMC?***

The survey is in. Twenty-three members have returned responses since our informal survey appeared in the October issue of the Denvair News. The results are tabulated in **red print** on the following survey pages by line item. Many thoughtful written notes were also returned, which are difficult to summarize accurately, but I'm going out on a fairly sturdy limb with a short list of initial conclusions:

- 1) Monthly club meetings are preferred;
- 2) The current Friday evening time slot is definitely NOT preferred;
- 3) Meeting location and venue preference lean to "variable", with Saturday morning getting 8 votes;
- 4) There's little desire to change the current list of annual activities;
- 5) The prevailing message seems to be: 'When in doubt, maintain the status quo'.

#### **So, will RMC be leaving Elway Chevy on first Fridays?**

That seems to be the direction RMC wants to go, but there are some fairly serious challenges to altering the current meeting status quo. First and foremost, identifying, contacting, and interacting with regularly-shifting meeting locations will require a good deal of consistent administrative attention. We should also be aware that dedicated meeting rooms typically require a 'head count' in advance for their own planning purposes, and RMC will be on the hook for food and beverage charges when attendee count and purchases don't meet pre-established minimums.

Personal notes added by roughly a third of the survey respondents showed a strong yearning for the days when we parked in open lots and chatted around the cars before the meetings. That was a regular thing at Elway (and Burt, originally!) Chevrolet a decade or two back, but times are changing. The Internet and trend to leasing have disrupted showroom sales, and instantaneous communication and AI may be delivering knock-out hits to traditional automotive dealerships soon...

#### **Keep It Going**

It was gratifying to see that the "Heck With It!" strategy was pretty much panned. RMC remains a viable club, and we even have a handful of youngsters (which I define as People Under 50 Years!) to replace the fan belts in the future.
